

Vehicle Rental Agreement

The following rental agreement is made between: INTERCAR UGANDA Limited (hereinafter is called the 'owner') and, represented by self (hereinafter is called the 'client'). - Clients Telephone No Physical Address.....

The owner has agreed to rent a..... Registration no to the client as set forth below:

1. Basic Agreement

1.1. The owner will provide the aforementioned vehicle, complete with fully comprehensive insurance (the excess of 25% will apply for self-drive, in case of an accident), and a complementary driver (when requested for in Kampala /Entebbe) to the client. A client on self drive will be responsible for any damage loss of the vehicle in so far as such damage is not covered by the comprehensive insurance- (Drink Driving, Over speeding over 80kms/hr & 40kms/hr on the Murrum Roads & National Parks & Careless Driving).

1.2. The contract will be in effect from to for a period of day(s).

1.3. The agreed upon rent for the rental of the aforementioned vehicles is at..... USD and a security deposit of NIL will be made for the vehicle refundable on return & checking of the vehicle. Vehicle is hired from the respective days to end of agreement, whether or not the vehicle is used. No refund will be made after commencement of rental for bookings, unless mentioned at the time of payment.

2. Obligations of the Owner

The owner agrees to:

2.1. Ensure the vehicle is legal and taxed according to local laws.

2.2. Ensure the vehicle is roadworthy and secure and complies with standards set out.

2.3. Ensure there is fully comprehensive insurance and that the lessee's representative is covered by this as a named driver.

2.4. Ensure the vehicle has a basic tool kit and spare tyre.

2.5. Provide and pay for a driver (if required) who meets the person specific requirements set (Optional).

2.6. Ensure the driver complies with the agreed terms of employment set (Optional).

2.7. Replace the driver if he fails to meet with the person specific requirements or the terms of employment set (Optional).

2.8. Arrange and pay for routine servicing on site every 3000 kilometres and any repairs and maintenance over and above the lessee's obligations set.

2.9. Provide a replacement vehicle if the original vehicle is unavailable for repair, maintenance or legal reasons.

3. Obligations of the client

The client agrees to:

3.1. Pay the rent as set out in section 1.

3.2. When driving the car, drive with due care and attention and in compliance with local laws if on self drive and check the vehicle to ensure roadworthiness prior to taking on the rental. To ensure that when driving on rough surface extra care is taken not to damage vehicle. Any damage due to careless driving will be charged to client. Use of the vehicle for game drives is done at the clients own risk. Client should note that most Uganda towns have humps and should take caution when driving. Speed Limit is 80Kms/hr & 40Kms/hr on murrum roads. Vehicle should be cleaned before returning it to INTERCAR.

3.3. Pay for petrol / diesel, oil, water and lubricants. Vehicle is hired dry. Do not to smoke in the vehicle.

3.4. Not to mount any fixtures, such as radio equipment, to the vehicle without the prior written agreement and direction of the lessor.

3.5. Pay any fines for traffic offences/infringements incurred whilst driving the car. Loss, damage and excess insurance applies for self drive

3.6. Have a valid driving licence (**Drivers Age 21 Years and Above**) and passport copy submitted to and approved by INTERCAR if on self drive. (Motor Vehicles when not driven by INTERCAR drivers should be used in a skilful and proper manner by properly skilled, trained, qualified and competent persons and in accordance with any operating instruction or manuals issued for the Motor Vehicles having signed the contract and submitted a copy of their driving permit and passport to INTERCAR). The designated driver will be expected to check water & oil levels of the vehicle when in use for over two days. For any repair works permission has to be sought from INTERCAR and receipts provided for reimbursement. Vehicle will have to be brought to Kampala for every servicing. Please read service card.

Ensure that, in event of an accident (when on self drive the client will protect the interests of INTERCAR by following the appropriate procedures of reporting the accident, involving the police where necessary and supporting insurance claims & to report to the nearest Police Station and INTERCAR in writing within 48 hours of any damage to or loss of the Motor Vehicles. Should the client fail to do so INTERCAR will at its sole discretion require the client to be responsible for such damage or loss.

To use the Motor Vehicle only within the borders of the Republic of Uganda.

For any part of the motor vehicle destroyed, damaged or lost due to reckless/careless/unprofessional driving, driving under the influence of alcohol, apart from minor damages, the client shall repair and replace with genuine parts at his/her/their cost, for vehicles on self drive.
