

Europear in the UK maintains Gold CEMARS certification for 7th year

Europear in the UK, has maintained its GOLD CEMARS (Carbon & Energy Management and Reduction Scheme), audited by Achilles in the UK. The CEMARS certification demonstrates Europear's commitment in the UK to measuring, managing and reducing greenhouse gas emissions

CEMARS is one of the world's most rigorous carbon reduction programmes. Independently audited, CEMARS offers certification to the globally recognised ISO 14064 standard for carbon management. The scheme allows companies to measure and monitor their greenhouse gas emissions and put in place plans to reduce them across design, development, management and reporting within an organisation.

Since 2010, the base year for Europear in the UK's CEMARS measurement, it has achieved an 8.4% reduction in emissions intensity (tCO2e/£million revenue). This reduction has been achieved through more accurate reporting, which helped to identify areas of the business with unnecessary spend and emissions.

By measuring utilisation effectively, Europear in the UK makes better use of its fleet and improves its mobility solutions. Combined with increased customer awareness, supported by its 'Environmental Month' awareness campaign, and tighter control on costs at individual sites, this helped drive down emissions.

Gary Smith, Managing Director of Europear Mobility Group in the UK, comments: "Certification to CEMARS for the seventh year running, confirms our ongoing commitment to robust and credible monitoring and managing of our emissions.

"Key targets set by Europear UK to reduce greenhouse gas emissions over the coming years, include reducing the average fleet CO2 figure; reducing average vehicle emissions for non-revenue movements. In addition, we aim to improve awareness of electricity / water usage and efficiencies. Once again Europear UK is leading the way in creating a more sustainable organisation, as part of a proactive approach to reducing the environmental impact of our transport solutions."
