COVID-19:

Europear Mobility Group UK acted quickly to a plea for help from Ipswich based community interest company Lofty Heights, providing two vans free of charge and thereby enabling them to continue the provision of services to the community during the Covid-19 pandemic.

Disaster struck when the fuel pump went on one of the social enterprises' vans, closely followed by an issue that grounded their second vehicle. With both vehicles off the road they were faced with being unable to carry on their work; helping the NHS, local authorities, charities and housing associations to provide specialist support to more vulnerable people living in our area.
